

Inter-County Rifle League
League Meeting – Minutes, Sunday, March 27, 2011

Neal Showalter, League President, called the meeting to order at 2:02 PM.

Clubs present – New Holland, York, Palmyra, and Columbia. Seitzland was not represented.

Treasurer's Report was presented by Dean Kreamer. There is a balance of \$3790.36 with another balance of \$788.80 in the Scholarship Fund.

Dean questioned as to how long he should retain old statements. It was voted to keep the records for seven (7) years. Motion by George Schucker, seconded by Ken Guffey.

The Minutes from the Fall Meeting were read and approved. Motion by Paul Irvin, seconded by Ken Guffey.

Old Business:

A check in the amount of \$600.00 was given to Bill Burkert, New Holland Club, to purchase trophies and food.

New Business:

The 2011 Outdoor Schedule was presented and discussed. The Fall League Meeting will be held immediately following the Saturday, August 13 match at Seitzland. Motion by Paul Irvin, seconded by Ken Guffey.

The Skill Development Day at Palmyra will be held on Saturday, April 16 at 12:00.

The ICRL Scholarship Award was discussed. The sole candidate, Briann Derr, of the Palmyra team was found to be an outstanding candidate and was voted to receive the 2011 Scholarship in the sum of \$1000.00. Motion by Paul Irvin, second by Ken Guffey.

Ken Guffey discussed the problems of funding shooting activities in the high schools. Ken indicated that the Columbia Club will be making a greater effort to recruit new junior shooters. He suggested that every team develop a junior shooting program in order to aid in the continuity of our sport. The NRA and CMP were remarked as having people available to help with this initiative. It all comes down to people making it happen.
