Inter-County Rifle League League Meeting Minutes Sunday, August 23, 2009

Neal Showalter, League President, called the meeting to order at 1:55 PM. All clubs, Columbia, Lebanon, New Holland, Palmyra and Seitzland, were represented.

The minutes from the Spring Meeting were read and approved after correcting the treasury balance.

Dean Kreamer gave the Treasurers report which was approved.

Old Business

NRA affiliation was discussed. Per Erin Gestl's belief, the League is already NRA affiliated as all the teams in the League are from clubs which are NRA affiliated. This may negate the need to pay a separate \$35 per year annual fee. The possibility exists that individual shooters, who so desire, can pay \$7.00 to the NRA and have their scores submitted to the NRA by the League for classification purposes. A motion was passed 6-0 to put this in motion. Erin Gestl to follow up on this and Bill Burkert, League Secretary, to assist.

The indoor target was discussed. The A36 will continue to be available even though it will not be "recognized" target by the NRA. The League will continue to use the A36 for this year 2009 - 2010, as previously decided. For various reasons, a vote on possibly adopting a different target was tabled until the Spring Meeting.

The ICRL Scholarship was discussed. After reviewing and modifying a proposal developed by a committee composed of Erin Gestl, Doug Nace and Bill Burkert, a point system was adopted to assist in identifying and rewarding qualified applicants.

New Business

It was decided 6-0 to allow the shooter to fire his any sight match on the A25 two bull target in lieu of the moonlight target during night matches.

The University Club was eliminated from the rotating banquet schedule. The banquet schedule is as follows: 2010 York 2011 New Holland 2012 Palmyra 2013 Lebanon 2014 Columbia

2015 Seitzland

As per the example set for us by Seitzland at the May 2009 banquet, high junior awards will be given for each of the 3P positions and the 3P aggregate, as well as high outdoor junior. It was also decided that open class shooters will receive one trophy or plaque even if they win multiple events. The single plaque would list their accomplishments.

Neal Showalter, Lebanon, discussed the possibility of using range facilities in Manheim as the new home for the displaced Lebanon Club. He must meet with members from his own team to get their input, but he was favorably impressed with the people at the Manheim facility. Unfortunately, the Manheim range has only five firing points. This creates logistical problems in completing matches prior to the 11:00 curfew for firing shots at this range. The league leaders discussed this problem and it was agreed to consider, if necessary, the commencement of shooting prior to 7:00 even without a full relay at this range. Concern was expressed regarding this violation of League Rules but at this point it was deemed appropriate in order to allow Neal to pursue this possible home for their team. Naturally, this will require further discussion, if necessary, in the future.

It was agreed that team rosters will include any shooter who shot in at least one match the previous year. Any additions to the roster can be made prior to the first match by notifying the League Secretary, preferably via email. Any shooter not on the roster at the beginning of the year will need to shoot in two matches in order for the score to count at the second match.

Two indoor schedules were presented. It was decided to adopt the schedule which lengthened the season but in turn provided some Friday nights off during the 20 match season.

The meeting adjourned at 3:49 PM.
