**Old Business**

- Bob read the minutes from the March 27, 2011 meeting. Correction: The balance of \$3,790.36 includes the scholarship fund.  
Currently, the scholarship fund amounts to \$549.10 which does not include a contribution from Seitzland.  
The motion to approve the minutes was made and seconded by Dean and Doug respectively.
- Dean mentioned the president cannot serve more than 6 consecutive terms. The Vice President succeeds the President the following year. The election of officers shall be completed at the autumn meeting. All 3 statements shall be included in the agenda for evaluation at our next meeting. If valid, they shall be documented on our website under "ICRL Rules in Addition to NRA Rules".

- The Board agreed the match fees will remain the same (\$3.00).
- Erin agreed to design a Hall of Fame Certificate which will be awarded to existing and future members.
- Handicapped individuals will be allowed to participate in matches provided they comply with NRA Small Bore Rifle Rule 13.1 "Physically Disabled Shooters".

- The Board agreed to create an Inter-County Rifle League Mission Statement. Bob read 2 versions submitted by Bob and Bill which will be included in the agenda for the spring meeting. League members may also submit their own versions to the League Secretary.
- Erin will schedule a Skill Development Day in October. Details will be forthcoming.
- The 2011/2012 indoor schedule will be distributed. Submit any conflicts to the League secretary.

### **Safety**

- Members are encouraged to use the rifle racks at indoor ranges whenever possible. (Editor's Note: NRA GUN SAFETY RULES "Store guns so they are not accessible to unauthorized persons".)
- New Holland will establish an outdoor ready line where the parking lot meets the bank. There shall be no rifles forward of this line until the command "You may move your rifle to the firing line". York will consider the same. The tables and benches for all other outdoor ranges will be the ready line.
- The empty chamber indicator (ECI) rule will be included in the outdoor rules. Be advised that this is a mandatory NRA rule 3.21.
