#### HALL OF FAME INDUCTION

#### 1.0 Purpose

1.1 The purpose of this procedure is to select ICRL members for induction into the ICRL Hall Of Fame.

#### 2.0 Definitions

2.1 ICRL – Inter-County Rifle League

#### 3.0 ICRL Hall of Fame Committee

- 3.1 This committee administers the procedure and consists of one representative from each member Club:
  - Lebanon Rifle Club
  - York Riflemen
  - Columbia Fish & Game Assn.
  - Palmyra Sportsmen's Assn.
  - Seitzland Rifle Club

#### 4.0 Eligibility

- 4.1 Candidates shall be active and former members of the ICRL.
- 4.2 Committee persons shall automatically be candidates for induction.

#### 5.0 Responsibilities

- 5.1 The ICRL Team Leaders shall complete the ICRL Hall of Fame Candidate Form and submit to the Hall of Fame Committee Chairman.
- 5.2 The attributes listed on the form shall be based upon the achievements <u>primarily</u> involved with the ICRL. Achievements outside the ICRL can be considered.
- 5.3 Achievements include, but not limited to:
  - Contributions to improve the ICRL specifically and to the shooting sport in general.
  - Shooting performance
  - Coaching
  - Participation in ICRL events
  - Tenure
- 5.4 The committee shall review the candidate form(s) for approval.
- 5.5 The committee chairman shall announce the inductees at the next banquet.

5.6 The website manager shall revise the website Hall of Fame page to include the new inductees.

#### 6.0 Forms

6.1 ICRL Hall of Fame Candidate Form – Used to document the achievements of the candidate. 6.1.2 Additional pages may be used.

#### 7.0 Document Control

- 7.1 The controlling document for this procedure resides in the ICRL website www.intercounty.org.
- 7.2 Revisions to this procedure are updated by the website manager. A revision renders outdated versions obsolete.
